## **APRIL SOUND PROPERTY OWNER ASSESSMENTS:**

ASSESSMENTS - (Late Fee - \$35/quarter after grace period)

Developed - \$272.56 per quarter (due January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup>, and October 1<sup>st</sup>) = \$1,090.24 per year.

Undeveloped - \$191.02 per quarter (due January 1<sup>st</sup>, April 1<sup>st</sup>, July 1<sup>st</sup>, and October 1<sup>st</sup>) = \$764.08 per year.

## **TRANSACTION FEES FOR ALL SECTIONS PER LOT, PER TRANSFER DEED:**

TRANSFER FEE:

Developed or Undeveloped - \$350.00 due at closing. - **MANDATORY**

RESALE CERTIFICATE:

Developed or Undeveloped - \$300.00 (7-10 business days). \$350 Rush (2-6 business days) – **DUE IN ADVANCE**

REFINANCE FEE:

Developed or Undeveloped – no charge.

PUD FEE:

\$100.00 due when requested in writing. - **DUE IN ADVANCE**

## **TENANT FEES:**

Tenant Administration Fee - \$75.00.

Tenant Gate Tag - \$25.00/Vehicle. – Purchase and/or Activation.

Tenant Decal - \$2.00/Vehicle. – Initial Purchase and Renewal Each Year.

## **AUTOMOBILE TAGS AND FEES:**

April Sound Property Owners Association Vehicle Decal - \$2.00 per vehicle (over 5 vehicles).

April Sound Property Owner Association Gate Access Tag - \$25.00 per vehicle.

April Sound Property Owner Association FAMILY Access Tag - \$75/initial fee - \$25/annually – MAX 2

Toll Tag Activation Fee - \$25.00 (no charge for Property Owner).
